## §1 General Principle

This general principle is not a part of the constitution of the association. It regulates only the mandatory membership fee as well as other fees and levies. It can be edited either by the full board of the association or upon submitting a request in the general assembly.

## §2 Resolutions

- (1) The full board decides the amount of membership fee, the admission fee and the levies. Also, the full board determined the fees.
- (2) The determined membership fees will be imposed on the first of January of the following calender year that follows its adoption. With the approval of general assembly, another date can be selected.

## §3 Membership Fees

- (2) The amount of membership fee depends on the statues of the member on the due date.
- (3) Applications for discount of membership fee under classes 1 and 2 should be accompanied with suitable documents that proves this statues. The board shall decide on the classification within the above-mentioned amounts.
- (4) The following documents can be considered as verification for each class for receiving a discount (copies are sufficient):

- Class 1: Student identification or copy of Bachelor/Master degree certificate + further requirements that the board entails to support the application.
  - Class 2: Student identification + further requirements that the board entails to support the application.
  - Class 3: Copy of Bachelor/Master degree certificate or proof of employment in case this employment was not known to the board.
- (5) Changes of the personal information should be informed as soon as possible, especially for those under the classes 1 and 2.
- (6) ~~If the member resides in Germany, the membership fee will be charged, upon signing debit authorization, from the current account of the member on 01.04. of each year. Under a request of the member, it is possible to pay the fee using bank transfer until 01.04. In case the member resides in another country, the member has until 01.04. to transfer the amount.~~ **The membership fee must be paid until the 1<sup>st</sup> of April via bank transfer.**
- (7) In case warnings for delayed payments are issued, the warned member carries the incurred costs resulted from each reminder.
- (8) Joining the association after 30<sup>th</sup> of June entails the payment of half of the fee.
