Assignment Place Remark

#### **Living Conditions**

Bamako is a non-family duty station with a difficult security and working environment. Mali is a non-family duty station. Living conditions are acceptable in Bamako, but security instructions need to be strictly complied with. Adequate housing is available for rent at US\$ 500-1500 per month. The national currency is the Franc CFA (February 2013 exchange rate was 1 US\$ = 490 FCFA). Visa credit cards are accepted in some hotels and larger shops. Mali is a country prone to malaria, so mosquito nets are highly recommended. Basic medicines are available from pharmacies, but provision needs to be made for specialized medication.

Security recommendations from the UN Department of Safety and Security (UNDSS) must be followed by all UN Staff in the course of their assignments in Mali.

For the sake of rewarding experience, UN volunteers in MINUSMA carry out their duties with flexibility, commitment, and a willingness to live and work in challenging conditions including heat and limited water and electricity supply.

#### **Organizational Context & Project Description**

The main task of the Gender Advisory Unit (GAU) is to:

1) Support gender mainstreaming by providing ongoing technical advice, capacity-building and training support to personnel and fulfill reporting obligations work; and

2) Support the full participation of women in the peace process and ensure that gender concerns are addressed in the stabilization process. The most recent mandate Resolution 2227 (2015) OP 23 requests MINUSMA to take fully into account gender considerations as a cross-cutting issue throughout its mandate and to assist the Malian authorities in ensuring the full and effective participation, involvement and representation of women at all levels and at an early stage of the stabilization phase, including the security sector reform and disarmament, demobilization and reintegration processes, as well as in reconciliation and electoral processes and further requests MINUSMA to assist the parties to ensure women's full and active participation in the implementation of the Agreement.

During the performance of the tasks under this assignment the UN Volunteer will be dealing with members of the internal Gender Task Force, Gender Focal Points of the different sections and components of MINUSMA, UN Women and other members of the UN Country Team, representatives the Ministry of Women Affairs and of Civil Society Organizations, the peace keeping training center "Ecole de Maintien de Paix – Alioune Blondin Beye" (EMP-ABB), the EU police training mission EUCAP and others involved in the implementation of the women, peace and security mandate set out by UNSCR 1325(2000) and follow on resolutions.

#### **Task description**

Under the direct supervision of the Senior Gender Advisor, the UNV Gender Affairs Communication Officer, will undertake the following tasks:

Design and develop the internal MINUSMA communication strategy for the Gender Advisory Unit (GAU) and lead and advise the planning and design an effective national information campaign on women, peace and security (WPS); Provide regular Training of Trainers (ToT) sessions for Gender Focal Points, Gender Task Force members and the Integrated Mission Training Cell (IMTC) and carry out gender in peace keeping operations (PKO) induction and specialized gender trainings as and when required;

Ensure the consistency of the GAU training programme, develop, evaluate and update the different training modules regularly ensuring their adaptation to the local mission and country contexts and their conformity with DPKO guidelines and produce regular reports on GAU training activities;

Ensure that the GAU trainings for national and international partners, particularly Malian Defence and Security Forces (MDSF), on gender and WPS issues are coordinated and synchronized with trainings on similar subjects developed by external partners: EMP-ABB, EUCAP, UN Women and others;

Compile quarterly reports to UNHQ, prepare weekly reports and GAU contributions to the SG report, weekly sitreps of other components and other reports as and when required;

Collect and analyze information regarding the position of women in Mali, their role in the peace process and other issues related to WPS from diverse sources and help integrate this information in MINUSMA reports and trainings;

Organize the production and distribution of regular newsletters and other communication materials related to women, peace and security, gender in PKO and related issues or activities of the GAU in collaboration with Mission counterparts, including the collection of photo and graphic materials;

Manage the organization of conferences, seminars and press briefings and prepare briefing materials for such events, including the organisation in coordination with relevant counterparts of annual events such as the Open Day on WPS and International Women's Day;

Perform any other duties as assigned by the SGA, based on the GAU work plan;

When working with (including supervising) national staff or (non-)governmental counterparts, the incumbent should set aside dedicated time for training, coaching, mentoring and capacity development.

#### Conditions of Service for International Specialist:

The contract lasts for the period indicated above with possibility of extensions subject to availability of funding, operational necessity and satisfactory performance. However, there is no expectation of renewal of the assignment.

A UN Volunteer receives a Volunteer Living Allowance (VLA) which is composed of the Monthly Living Allowance (MLA) and a Family Allowance (FA) for those with dependents (maximum three).

The Volunteer Living Allowance (VLA) is paid at the end of each month to cover housing, utilities, transportation, communications and other basic needs. The VLA can be computed by applying the Post-Adjustment Multiplier (PAM) to the VLA base rate of US\$ 1,587. The VLA base rate is a global rate across the world, while the PAM is duty station/country-specific and fluctuates on a monthly basis according to the cost of living. This method ensures that international UN Volunteers have comparable purchasing power at all duty stations irrespective of varying costs of living. The PAM is established by the International Civil Service Commission (ICSC) and is published at the beginning of every month on the ICSC website http://icsc.un.org.

In non-family duty stations that belong to hardship categories D or E, as classified by the ICSC, international UN Volunteers receive a Well-Being Differential (WBD) on a monthly basis.

Furthermore, UN Volunteers are provided a settling-in-grant (SIG) at the start of the assignment (if the volunteer did not reside in the duty station for at least 6 months prior to taking up the assignment) and in the event of a permanent reassignment to another duty station.

UNV provides life, health, permanent disability insurances as well as assignment travel, annual leave, full integration in the UN security framework (including residential security reimbursements).

UN Volunteers are paid Daily Subsistence Allowance at the UN rate for official travels, flight tickets for periodic home visit and for the final repatriation travel (if applicable). Resettlement allowance is paid for satisfactory service at the end of the assignment.

UNV will provide, together with the offer of assignment, a copy of the Conditions of Service, including Code of conduct, to the successful candidate.
