# Third statute on amendment on the examination regulations for the

## Bachelor's program at Faculty I: The School of Arts and Humanities

of the University of Siegen

of June 23, 2020

On the basis of § 2(4) and § 64(1) of the Act on Higher Education Institutions of the State of North Rhine-Westphalia (Higher Education Act - [HG]) dated September 16, 2014 (Laws and Regulations [GV.] NRW. p. 547), last amended by the Law of April 14, 2020 (Laws and Regulations [GV.] NRW. p. 218b) the University of Siegen has issued the following amended regulations:

The examination regulations for the Bachelor's program at Faculty I: The School of Arts and Humanities of the University of Siegen dated March 12, 2013 (Official announcement 20/2013), which was last amended by the second statute amending the examination regulations for the Bachelor's program at Faculty I: The School of Arts and Humanities of the University of Siegen dated May 18, 2017 (Official announcement 52/2017), is amended as follows:

### Article 1

(applies to students who enrolled for the first time in a Bachelor's program of Faculty I before the winter semester 2014/2015)

- 1. In §8 (14) sentence 4, the word "LSF" is replaced by the word "Campus Management System".
- 2. § 10(4) is amended as follows:
  - a) The following sentence 3 is added:

"Registration for the performance of the examination in the last possible retake attempt requires a separate registration via the examination office and is not possible via the campus management system in accordance with § 8(14)."

b) The new sentence 5 is replaced by the following sentences 5 to 8:

"At least one retake opportunity must be offered in the same semester for coursework or examinations in a Faculty I module. In the case of the forms of performance listed under § 8(7) number 2 as well as (8) number 5, only two dates must be offered in the same semester. Students who attend the first appointment may use the second appointment as a retake opportunity. Students who attend only the second appointment are not eligible for another appointment in the same semester."

3. In Appendix 1: Subject catalog, the table "Combination program model: Possible combinations core subject + supplementary subject" is amended to read as follows:

### Article 2

(applies to students who enrolled for the first time in a Bachelor's program of Faculty I from the winter semester 2014/2015)

- 1. § 8(14) sentence 4 is amended as follows:
  - a) The word "LSF" is replaced by the word "Campus Management System".
  - b) The word "lecturers" is replaced by the word "teaching staff".
- 2. § 10(4) is amended as follows:
  - a) The following sentence 3 is added:
    - "Registration for the performance of the examination in the last possible retake attempt requires a separate registration via the examination office and is not possible via the campus management system in accordance with § 8(14)."
  - b) The new sentence 5 is replaced by the following sentences 5 to 8:
    - "At least one retake opportunity must be offered in the same semester for coursework or examinations in a Faculty I module. In the case of the forms of performance listed under § 8(7) number 2 as well as (8) number 5, only two dates must be offered in the same semester. Students who attend the first appointment may use the second appointment as a retake opportunity. Students who attend only the second appointment are not eligible for another appointment in the same semester."

#### Article 3

- 1. This amendment regulation comes into force on October 1, 2020. It will be published in the University's official gazette "Amtliche Mitteilungen der Universität Siegen" ("Official Announcements of the University of Siegen").
- 2. The amendments pursuant to Article 1 No. 1 and No. 2a and pursuant to Article 2 No. 1 and No. 2a shall apply to all students from the winter semester 2020/2021.
- 3. The amendments pursuant to Article 1 No. 2b and Article 2 No. 2b shall apply to all students from the winter semester 2021/2022.
- The amendments pursuant to Article 1 No. 3 and Article 2 No. 3 shall apply to students enrolling from the winter semester 2020/2021 onwards.

Issued on the basis of the resolution of the department council of Faculty I - The School of Arts and Humanities - of May 6, 2020.

Attention is hereby drawn to the point that, pursuant to § 12 Paragraph 5 of the Act on Higher Education Institutions in the State of North Rhine-Westphalia (Higher Education Act [Higher Education Act [HG]]), the assertion of any claim pertaining to a violation of procedural or formal regulations of said Higher Education Act, or of the University's regulations (or other autonomous law), may no longer be asserted after a period of one year has elapsed since this announcement, unless

- 1. the statute has not been properly published
- 2. the Rectorate has previously objected to the resolution of the body adopting the statute,
- 3. the University has been notified in advance of a formal (or procedural) defect, indicating the legal provision that has been violated and the circumstance giving rise to said defect, or
- 4. no reference was made to the legal consequence of the exclusion of any notification of defects in the public announcement of the statute.
