Information Sheet for Guest Auditors at the University of Siegen

Persons interested in hearing individual subjects without being enrolled as degree students can be admitted as special auditors within the framework of the available curriculum . In this case a higher education entrance qualification is not required.

The professor responsible for the course decides on admission. Special auditors are not entitled to be graded on exams; they can only receive an attendance certificate.

Participants of the training offer "German as a Second Language" (DaZ) are exempt from the tuition fee. The approval of the respective lecturor or the DaZ authority must first be obtained in writing and be presented together with the application. To submit your application, or to receive the attendance certificate, please contact the DaZ authority at Faculty I (see: https:// www.uni-siegen.de/phil/germanistik/studium/daz).

Refugees can be exempt from the tuition fee.

Prodedure

You can enroll for a maximum of three courses, subject to availability of space. Please consult the respective lecturer beforehand.

Proper students always have priority concerning seminars, courses, labs, etc. In particular, you can not visit events in courses of study with admission restrictions.

In the LSF (Teaching, Studies, Research – Portal for students, those interested, and university members), you can see which lecturer is responsible for any particular course. Here you will also find the place and time of the event.

An LSF-Account is not created for auditors. However, even without an account, you have the possibility to see the virtual course catalogue in the LSF and to prepare a schedule. Please print out the schedule because your data will not be saved after leaving the LSF.

- Important Hints
- > You do not receive a semester ticket / NRW-Ticket or a student ID card

> As a special auditor you do not receive reductions for cinemas, museums or public pools, etc.

- Special auditors are not entitled to take exams
- Achieved merits (seminars, etc.-) will not be accredited towards possible study.

The participation in university sport and physical education is principally impossible for special auditors because there is no insurance coverage by the University of Siegen. Exceptions can possibly be granted, if you sign a non liability declaration. For more
